## **AGST Internship Programme 2016 Participant's Pledge**

I hereby undertake to comply strictly with the matters listed below in the course of my participation in a AGST Internship Programme 2016 (hereinafter, "programme") operated by Graduate School of Economics, Kyoto University (hereinafter, "the University").

1. I am applying for this programme based on full comprehension of the costs involved in conducting internship and with the advance permission of my financial sponsor.
2. My participation in this programme has been approved by my guarantor (relative, supervisor etc.).
3. I am in sufficient good health to engage in this programme and personally responsible for dealing with my health conditions during its term (Any pre-existing conditions or current medical treatments must be reported.)
4. I am personally responsible for dealing with any accidents occurring between my departure and return to Kyoto (Japan). I will also notify the University staff in charge of any such occurrences.
5. I am personally responsible for any liability for damage to property or person – caused by my own negligence between my departure and my return to Kyoto (Japan) after the programme.
6. I will take out Gakkenbai, Gakkensai or Futaibaiseki and overseas travel insurance (*Furaikaigaku*: Plan D) for covering the entire period of the trip from my departure until my return from and to Kyoto (Japan).
7. I understand that the University may decide to cancel or postpone my internship under this programme or order me to return to Kyoto (Japan), in light of public safety and other conditions in the country and/or region in which my host organization is located. In such cases I will comply with the University's directions promptly, and will not hold the University responsible for any loss or damage incurred as a result thereof, including cancellation fees and other applicable charges.
8. I fully comprehend the purposes of this programme and will devote myself to the work at the host institution/company.

9. \*While overseas, I will comply with the laws of the destination country and the regulations of my host institution(s), and behave as a responsible student of the University.
10. \* I also undertake to comply with the laws of Japan regarding consumption of alcohol. (Alcohol should not be consumed if under 20 years of age, regardless of the laws of the destination country).
11. \*I will not drive a motor vehicle under any circumstances (bicycles are acceptable). I will comply with all local traffic laws.
12. I will complete all procedures required as part of this programme by the due date without fail. These procedures include the payment of a cancellation fee if withdrawing from the programme.
13. After completing the programme, I will actively respond to requests from the University for assistance in promotional activities.
